GREETINGS:

To any of the Constables or Regular Police Officers of the Town of Chelmsford, or some other suitable person.

In the name of the Commonwealth, you are hereby required to warn and notify the legal voters of the North Chelmsford Water District to meet at the District Office at 64 Washington Street, North Chelmsford at 4:00 P.M. to act upon the following articles on Monday Evening, March 23, 2026,

ARTICLE 1. To choose a moderator.

ARTICLE 2. To hear the reports of the Board of Water Commissioners, the Treasurer, or act in relation thereto.

ARTICLE 3. To appoint a Clerk for the term of one year.

ARTICLE 4. To elect by ballot, one member to the Board of Water Commissioners for the term of three years.

ARTICLE 5. To see if the District will vote to raise and appropriate such sums of money as may be required to defray the District's charges for the current Fiscal Year beginning July 1, 2026, or act in relation thereto.

ARTICLE 6. To see if the District will vote to authorize the Treasurer, with the approval of the Commissioners, to borrow in anticipation of revenue for the Fiscal Year beginning July 1, 2026, in accordance with the General Laws, Chapter 44, section 17, or act in relation thereto.

ARTICLE 7. To see if the District will vote to transfer from Surplus Revenue the sum of \$100,000 (One Hundred Thousand Dollars) to the Water Tower(s) Maintenance Fund, or act in relation thereto.

ARTICLE 8. To see if the District will vote to transfer from Surplus Revenue the sum of \$50,000 (Fifty Thousand Dollars) to the OPEB Trust Fund, or act in relation thereto.

ARTICLE 9. To see if the District will vote to transfer from Surplus Revenue the sum of \$50,000 (Fifty Thousand Dollars) to the Residential Water Meter Account, or act in relation thereto.

ARTICLE 10. To see if the District will vote to transfer from Surplus Revenue the sum of \$500,000 (Five Hundred Thousand Dollars) to the Treatment Plant Maintenance Fund, or act in relation thereto.

ARTICLE 11. To see if the District will vote to transfer from Surplus Revenue the sum of \$40,000 (Forty Thousand Dollars) to the Per and Poly-Fluoroalkyl Substances (PFAS) Account, or act in relation thereto.

ARTICLE 12. To see if the District will vote to transfer from Surplus Revenue the sum of \$200,000 (Two Hundred Thousand Dollars) to the Truck Account, or act in relation thereto.

ARTICLE 13. To see if the District will vote to transfer from Surplus Revenue the sum of \$5,000 (Five Thousand Dollars) to the Retiree Buy Back Fund, or act in relation thereto.

ARTICLE 14. To see if the District will vote to transfer from Surplus Revenue the sum of \$500,000 (Five Hundred Thousand Dollars) to the Distribution Infrastructure Account, or act in relation thereto.

ARTICLE 15. To see if the District will vote to transfer from Surplus Revenue the sum of \$350,000 (Three Hundred Fifty Thousand Dollars) to the Garage Rehabilitation Account, or act in relation thereto.

ARTICLE 16. To see if the District will vote to amend Article 8 from the 1990 Annual Meeting to read as follows:

To see if the District will authorize the payment of Incentives for compensation to District Employees Beginning on July 1, 2026 for Commonwealth of Massachusetts issued Water Licenses as follows:

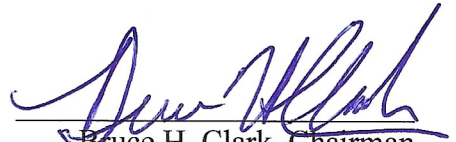

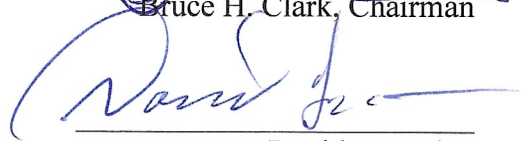

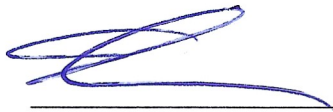
